Dear Parents and Guardians:

The New Jersey State Department of Health has mandated that all children entering any school district in New Jersey shall have the following immunizations:

*DPT (Diphtheria/Pertussis/Tetanus)* - Pupils born on or after January 1, 1986 - 4 doses DPT, including 1 dose on or after the 4<sup>th</sup> birthday or any 5 doses (or DT under age 7 with medical contraindication to Pertussis vaccine).

*Polio* - Pupils born on or after January 1, 1986 - 3 doses, including 1 dose on or after the 4<sup>th</sup> birthday - <u>or</u> any 4 doses - of live, trivalent, or oral vaccine (OPV).

*Rubeola/MMR (Old Fashioned Measles)* - Pupils born on or after January 1, 1990 - 2 doses of live vaccine - on or after 1<sup>st</sup> birthday, <u>or</u> laboratory evidence of immunity <u>or</u> medically certified history of disease. One dose minimum required for Preschool.

*Rubella/MMR (German Measles)* - one dose live vaccine - on or after 1<sup>st</sup> birthday, <u>or</u> laboratory evidence of immunity.

*Varicella* (*Chicken Pox*) - one dose of vaccine for children entering Kindergarten or Grade 1, born after January 1, 1998, *or* laboratory evidence of immunity.

*Mumps/MMR* - one dose live vaccine - on or after 1<sup>st</sup> birthday, <u>or</u> laboratory evidence of immunity.

*Haemophilis influenza type b (Hib) vaccine* – students entering Preschool must have received at least one dose of Hib, and have plans to complete the series within 16-17 months. The schedule depends on the type of vaccine used and when the child starts the series.

*Hepatitis B* – 3 doses of vaccine required.

## \*Requirement for PRESCHOOL ONLY \*

Pneumococcal – minimum of one dose is needed after the first birthday. Influenza – One dose to be given between Sept 1 and Dec 31 of each year.

\*\*Requirement for SIXTH GRADE students\*\*
Meningococcal conjugate- one dose
Tdap- one dose

PLEASE NOTE THAT IMMUNIZATIONS ARE REQUIRED PRIOR TO YOUR CHILD'S ENROLLMENT.
