#### A. MASKS

all students, employees, parents/visitors, no matter your vaccination status. Exceptions include the following as noted in the Order: Per Governor's Executive Order 251, starting on August 9, 2021, it is mandatory that face masks be worn indoors in all district and school buildings by

- a. When doing so would inhibit the individual's health, such as when the individual is exposed to extreme heat indoors;
- b. When the individual has trouble breathing, is unconscious, incapacitated, or otherwise unable to remove a face masks without assistance;
- pursuant to Section 504 of the Rehabilitation Act of 1973, precludes use of a face mask; c. When a student's documented medical condition or disability, as reflected in an Individualized Education Program (IEP) or Educational Plan
- d. When the individual is under two (2) years of age;
- e. When the individual is engaged in activity that cannot physically be performed while wearing a mask, such as eating or drinking, or playing a musical instrument that would be obstructed by a face mask;
- f. When the individual is engaged in high-intensity aerobic or anaerobic activity;
- g. When a student is participating in high-intensity physical activities during a physical education class in a well-ventilated location and able to maintain a physical distance of six feet from all other individuals; or

However, the CDC has an exception for close contacts in K-12 indoor classroom settings as follows: "the close contact definition close contacts - Per the CDC, close contact is defined as being within 6 feet of someone with suspected or known COVID-19 for 15 or more minutes information below.

In circumstances where masks are not worn, such as lunches, sports, etc., the following guidelines will be followed for close contacts:

Unvaccinated individuals identified as close contacts of an individual who tests positive for COVID-19 should be excluded from school and quarantine for 10 days, or 7 days with a negative test result collected at 5-7 days. If the community COVID-19 activity level reaches High, close

contacts should be excluded from school and quarantine for 14 days. Note: COVID-19 Activity Levels are determined by the New Jersey Department of Health

- Exposed close contacts who are fully vaccinated and have no COVID-like symptoms:
- Do not need to quarantine, be excluded from school, or be tested following an exposure to someone with suspected or confirmed COVID-19.
- Should still monitor for symptoms of COVID-19 for 14 days following an exposure.
- 0 If they experience symptoms, they should isolate themselves from others, be clinically evaluated for COVID-19, including testing and inform their health care provider of their vaccination status at the time of presentation of care.
