### **Board of Education Goals**

This brochure has been prepared to provide a better understanding of the actions that the Board of Education will take during a meeting. It is also intended to introduce you to the Board members and invite you to participate more fully in a Board meeting.

The Board of Education will follow an agenda previously prepared by the Superintendent. Copies are available at Board meetings as well as posted to the website at 5:00 p.m. on the Friday preceding the meeting.



#### THE BOARD OF EDUCATION

The High Bridge School Board of Education is comprised of seven elected representatives of the High Bridge community. Board members normally serve for a three-year term of office.

The Board is charged with the responsibility of acting as the general agent of the State of New Jersey in carrying out the will of the people of this community in the matters of public education. The Board of Education establishes educational goals for the children of the district and supervises all programs designed to meet these goals.

The Board is also responsible for enforcing policy. Where state law does not provide or prohibit, the Board is responsible for establishing, maintaining and apprising the public of educational activities of the school district.

The High Bridge Board of Education meets in public to determine the educational policies of the school district. The Board of Education provides an opportunity for the public to express their views at these meetings.

Please note that your Board of Education members are local residents who are serving you by devoting many unpaid hours of their time to our school district. Board members do not have authority as individuals and can act on school matters only at a regularly scheduled and advertised Board of Education meetings.

The School District's website at http://www.hbschools.org/ is an important resource for information and meeting dates, and there is a section for the School Board under the "School Board" tab. Meeting dates and important notices are also posted on the main page. Please visit the website frequently for any changes or information updates.

### **COMMUNICATING WITH YOUR BOARD**

Communication is best carried out at the meetings of the Board of Education.

The Board conducts a Work Session one week prior to its Regular Meeting. Work Sessions provide the opportunity for Board members to review items proposed for action at the Regular Meetings and to discuss and clarify issues. The Board operates as a Committee of the Whole at the Work Sessions. The Board then has the opportunity to obtain additional information needed prior to taking a formal vote on proposals at the Regular Meetings.

Agendas are available online or upon signing into the Board Meetings. The Work Session meeting agenda will always include one opportunity for members of the public to address the Board. At Regular Meetings, there are two opportunities to address the members of the Board. The first public comment period should relate to agenda items and the second public comment period can be on any topic.

If you wish to address the Board, raise your hand and wait for recognition by the President. State your name and address your remarks to the President. Individual members may be addressed upon recognition by the Board President. The Board, through individual members, may choose to respond to your comments.

Public comments are limited to three minutes. No individual may speak more than once on the same topic until all others who wish to speak on that topic have been heard. Written statements may be read to the Board and then given to the Board Secretary/ School Business Administrator to be included in the minutes of the meeting.
